

# Enterprise High School

## Parking Permit Application

The following rules apply to students bringing any vehicle to school.

1. In order to obtain a parking permit, students must provide a **completed and signed application**, the **current vehicle registration (tag receipt)**, **proof of insurance**, and a **valid driver's license**, and **pay a \$30 / \$15 for 2<sup>nd</sup> semester parking fee** (cash or check only – if paying online, receipt of payment must be received by school). Any changes to the vehicle being driven on the EHS campus must be reported to the administration.
2. A current parking permit must be clearly and visibly displayed on the rear view mirror of any vehicle parked on campus. Violations will result in a parking citation. Failure to see an administrator within two school days will result in further disciplinary actions. No excuses will be accepted for not displaying a parking permit. Students must not give/loan a parking decal to other students.
3. Students must leave their parked vehicles in the designated parking area and enter the school immediately after parking. You may purchase a parking space from the school for an additional fee – this space must be clearly marked and is in a designated area. Otherwise, there are no designated spots; a student **must park in their assigned lot** within the white lines (teacher parking areas are marked with signs). Students may not go into the parking lot during the school day without written permission from an administrator.
4. Campus speed limit is 10 MPH. Students must obey instructions given by school personnel directing traffic on school grounds. This includes student resource officers.
5. Vehicles are parked at the student's risk. Neither Enterprise High School nor the Enterprise City Board of Education assumes any liability for damage or loss to vehicles parking on school property.
6. **Drug Screening / Parking Privilege**: Only students who agree to be tested on a random basis for illicit drug and alcohol use may obtain a parking permit. I agree by this application to read the ECS Drug Screening Policy and to abide by its terms including the requirement for me to be tested on a random basis. I understand that high school officials conduct routine patrols of student parking lots and inspections of the exteriors of student automobiles on school property. Enterprise High School officials may inspect the interior of student automobiles whenever a school official has reasonable suspicion to believe illegal, unauthorized, and / or contraband materials are contained inside the vehicle.
7. **PARKING IS A PRIVILEGE – NOT A RIGHT**. Parking permits may be revoked due to disciplinary action at any time throughout the school year. Suspended or revoked privileges will not result in any refund of fees paid.

I verify that all the above information is correct and agree to comply with all parking rules and regulations listed above or those announced by a school administrator. Rules not followed will result in a violation.
